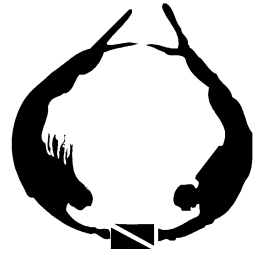

**RELEASE, WAIVER AND INDEMNIFICATION AGREEMENT
